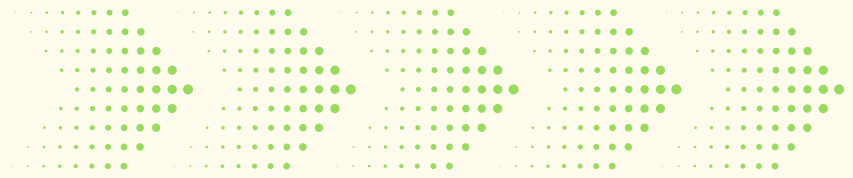

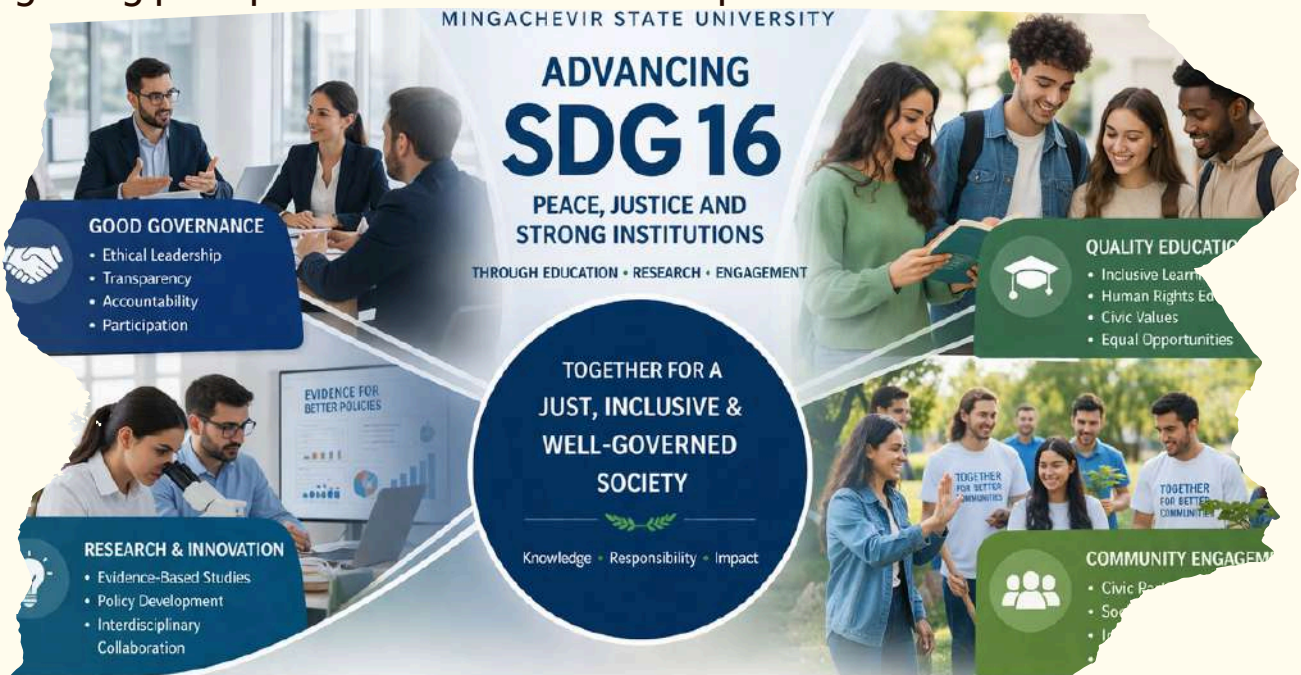

Students actively participate in seminars, workshops, roundtable discussions, debates, and research projects that simulate real-life governance, legal, and policy-making scenarios. These interactive learning environments enable students to apply theoretical knowledge in practical contexts, enhance their communication and teamwork skills, and develop innovative approaches to complex social and institutional issues. 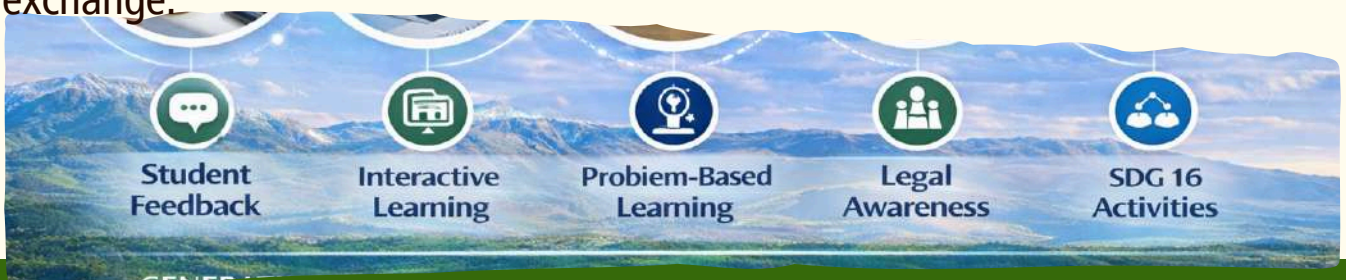

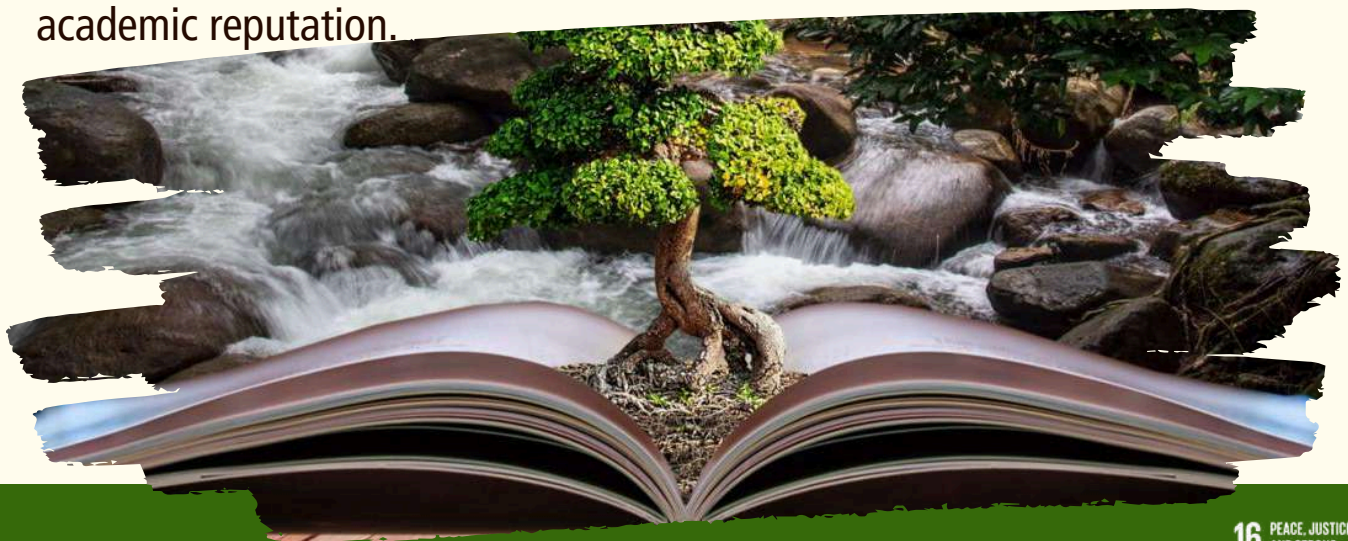
### 3.2 RESEARCH

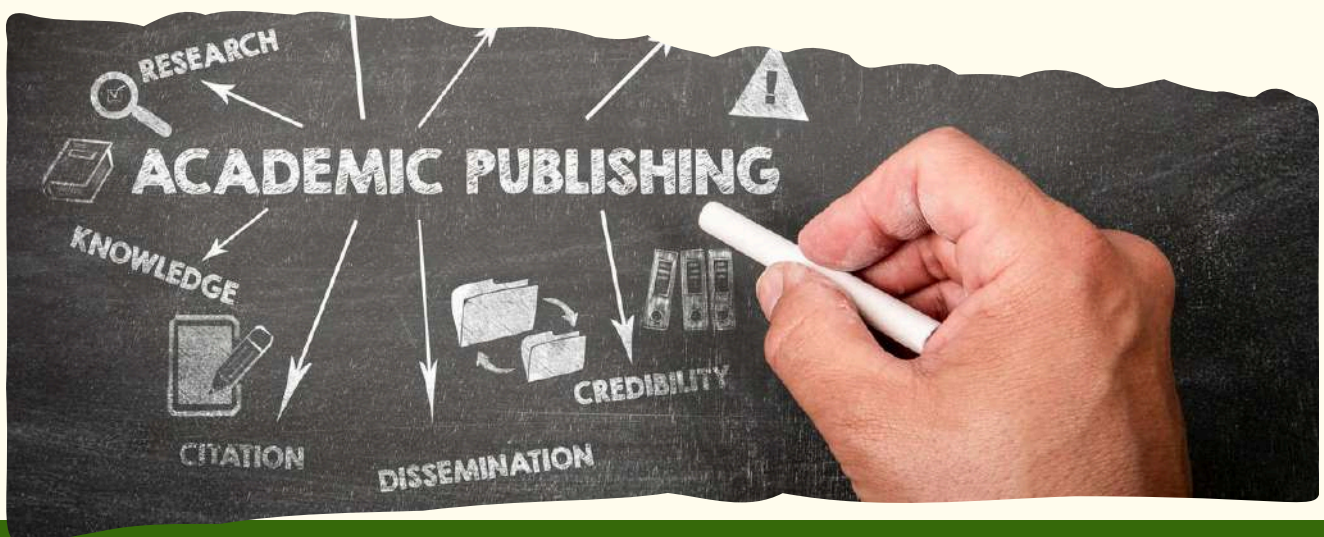


Scientific publications produced by MSU's academic staff are increasingly featured in both national and international peer-reviewed journals. In particular, the number of publications indexed in internationally recognized databases such as Scopus and Web of Science (WoS) has shown a steady upward trend. This growth reflects the continuous improvement in research quality, increased academic productivity, and the university's stronger integration into the global scientific community. It also demonstrates MDU's commitment to meeting international research standards and enhancing its academic reputation.



At the postgraduate level, Master's theses and doctoral dissertations cover a wide spectrum of topics directly related to SDG 16. Research areas include the rule of law, effectiveness and efficiency in public administration, ethical governance, civic engagement, anti-corruption strategies, and social responsibility.

Research centers and laboratories within the university play a crucial role in organizing, supporting, and advancing research activities. These institutional structures provide an enabling environment for interdisciplinary collaboration, academic dialogue, and innovation. Within these platforms, faculty members and students jointly participate in research projects, organize scientific seminars and discussions, and contribute to the development of new ideas and approaches related to governance and institutional development. The university also places strong emphasis on community-oriented and socially impactful student engagement. Similarly, innovation-driven platforms such as the “Social Health Innovation Competition” encourage students to develop creative, community-focused solutions to pressing social challenges. These initiatives not only enhance critical thinking and teamwork but also foster a proactive approach to addressing societal issues.

In addition, MSU regularly organizes training programs, seminars, and workshops aimed at enhancing knowledge and competencies related to governance, social responsibility, and institutional development. For example, training sessions on “Social Entrepreneurship and Community Projects” focus on project design, implementation strategies, and impact assessment, equipping participants with practical tools for developing sustainable initiatives.



Thematic activities such as trainings on “Protection and Sustainable Management of Water Ecosystems” further contribute to raising awareness about responsible resource management and environmental governance. Roundtable discussions on topics such as “Legal Foundations of Urban Planning and Architectural Activities” provide insights into regulatory frameworks, while student competitions like “Stereotypes-Free Staff” promote awareness of equality, inclusion, and anti-discrimination principles. MSU also plays an active role in supporting regional development through large-scale social initiatives. Programs such as “Future Together: Social Activity and Development Program”, which include youth forums and community engagement activities, aim to enhance legal awareness, civic participation, and social inclusion among young people. Through cooperation with local authorities, public institutions, and community organizations, the university contributes to addressing regional challenges related to governance, social cohesion, and institutional effectiveness.

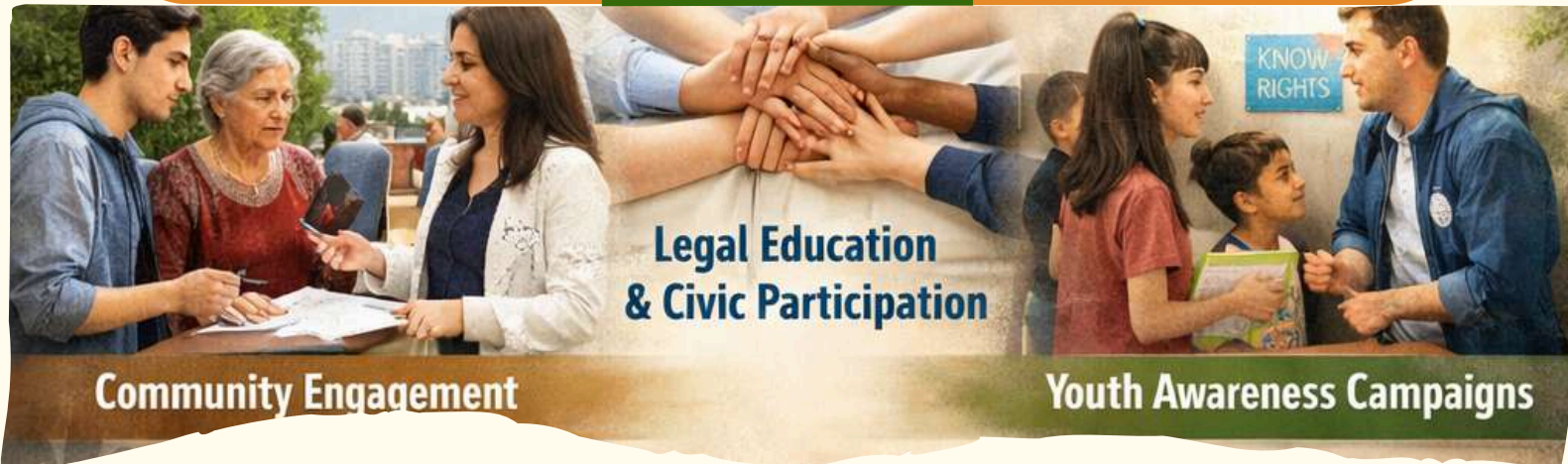

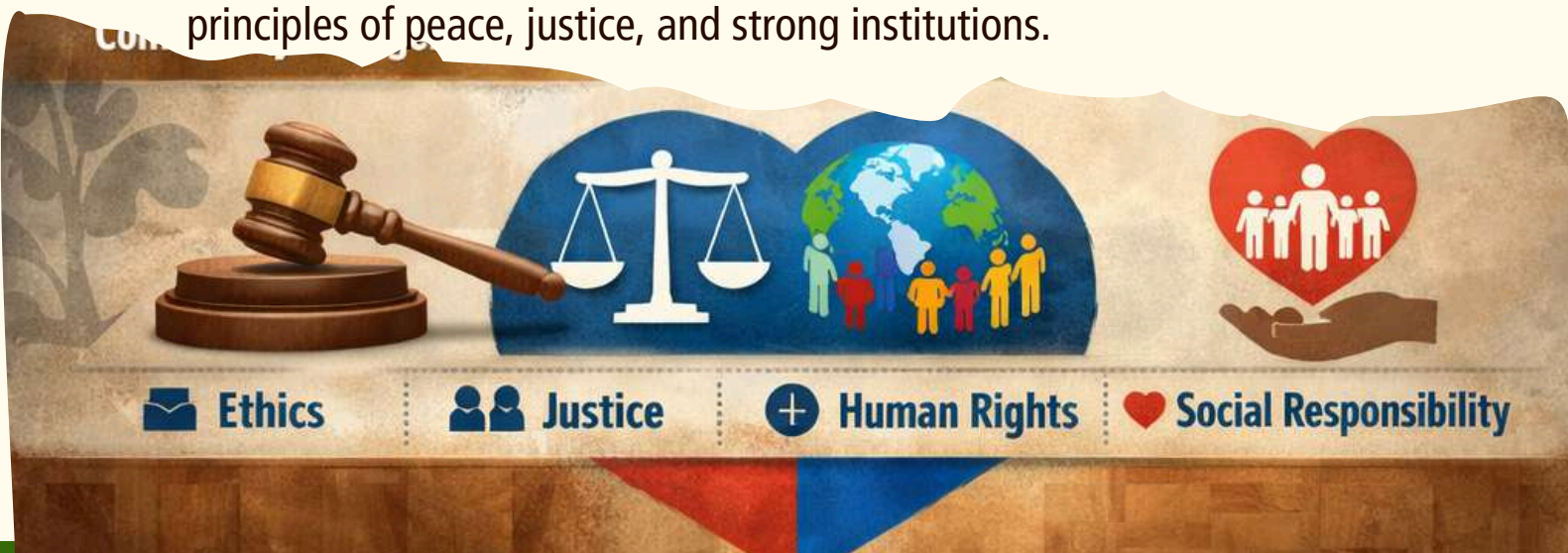
